Ongoing Assessment of Student Learning for All Universal Required Competencies

- The School of Public Service and the MPA program have a specific competency mapping and assessment cycle to measure universal competencies. Our mission statement maps into the MPA program's three major goals, which map to our learning goals and objectives. Those learning goals and objectives reflect one or more of the universal competencies.
- The table (below) "Curriculum Map of MPA Learning Objectives Assessment and NASPAA Competencies" - displays how each MPA program's learning objective is covered and how each objective meets a universal competency.
- Each of the eight objectives mapped to universal competencies is measured in a three-year cycle across seven of the eight (8) core courses.
- The assessment is accomplished for both NASPAA and SACS purposes and is displayed in the table "MPA Learning Goals, Assessment, and Competencies" (below). Some courses are not assessed yearly, as we are not required to use every core course for assessment, but selected courses (for example, 746) are assessed under varying objectives, depending on the year within the cycle.
- Note: Assessment of Student Learning for All Universal Required Competencies was updated in January 2023. The URC1 evaluation discussed in the Standard 5 narrative is based on the prior assessment plan, which mapped the ability to appreciate the complexity of operating in a multisectoral environment to a graded assignment in PADM701:Public Policy and Evaluation. This competency is now mapped to PADM746: Capstone Seminar in Public Administration.
